NOVEMBER/DECEMBER MEETING MINUTES

The November 8th meeting of the SVBC was held at the original Luigi's. There were six members present. The Treasurer reported a balance of \$7,750.04, less Century insurance.

There was no old business.

New business: A reminder that hunting season is in all the way through December for various game using various firearms. Hopefully one game species, mountain bikers, isn't legal. If you ride in the woods during these months, be visible -- and the best day to ride is Sunday. However, don't assume Sunday there won't be shooting. Be visible and make lots of noise. The west side of Massanutten is CLOSED except for Sunday, and patrolled. Keep the trails open for biking Massanutten by respecting this status.

The meeting was adjourned.

The December 13th meeting of the SVBC was held at El Charro's Route 11 South. Luigi's was closed for a staff party. There were eight members present and Jonathan from OCP to discuss plans for the Festival in July. One member was trying to attend but couldn't find us. That wasn't intentional Art, or was it....?

The Treasurer reported a balance of \$6,880.13 with the Century insurance bill finally received and paid.

There was no old business.

New business: Neups passed out copies of "Intrigue and Uncertainty" an article presenting a novel approach to making roads and neighborhoods safer for

all activities by creating activity zones and eliminating traffic guidance.

The Club will donate a copy of the League of American Bicyclists Guide to Safe and Enjoyable Cycling to the regional library and will renew membership in the Thunderhead Alliance.

The SMBC has reserved the Court Square Theatre again for the pre-Super Bowl Ride celebration. There will be a Century, Metric Century, two morning loops of 24 and 40 miles, an in-town tour or Greenway Ride (donations going to Black's Run Greenway) and, hopefully, a

Critical Mass Ride at the conclusion of the day's events. The Club will scout routes to present at a later meeting. This means many new loops for members to explore and mark before the Festival.

January's meeting will be a Pot Luck supper at Thomas and Julie's (E. Wolfe Street). Plans are for Drew Williams from the Harrisonburg Public

Transportation Department to give a short update on bicycling routes in the city.

The meeting was adjourned before Art could find us.

THUNDERHEAD PUBLISHES COMPLETE STREETS REPORT

Prescott, AZ – December 13, 2004 – The Thunderhead Alliance has published the first nationwide analysis of policies designed to create complete streets that routinely accommodate bicycle and pedestrian travel. The Complete Streets Report, prepared by consultant Barbara McCann, inventories complete streets policies around the country and analyzes them in preparation for the Thunderhead Complete the Streets Campaign Model to help state and local advocacy organizations spread complete streets to more communities. “Ensuring streets work for all users has always been a high priority for Thunderhead organizations,” said Thunderhead Executive Director, Sue Knaup. “This report gives advocates the latest information as they pursue this vision.”

Most of the 25 state and local policies in the report have been enacted since 2001, suggesting a building momentum for policies that require the safe accommodation of bicyclists and pedestrians in all transportation projects. The Report discusses the language used and elements included in the policies, as well as issues surrounding the process of adoption and implementation. It makes recommendations for advocates seeking to launch new Complete the Streets campaigns. Thunderhead has also posted on its website tips on using complete streets in everyday communications. Ms. McCann will soon start on the next phase of the Campaign Model funded by a grant from the New-Land Foundation.

The Report is Thunderhead’s first step in a national campaign to win complete streets policies through its member organizations. The Complete the Streets Campaign Model will be the focus of Thunderhead’s Training March 14-15 in Washington, DC (<http://www.thunderheadalliance.org/trainings05.htm>) in conjunction with the National Bike Summit® (www.bikeleague.org).

The Report is an integral part of Thunderhead’s comprehensive 50/50 Project with a goal of effective and sustainable bicycle and pedestrian advocacy organizations in all 50 states and at least the 50 top population U.S. cities. The 50/50 Project is made possible by the generous support of Planet Bike and the National Bicycle Dealers Association.

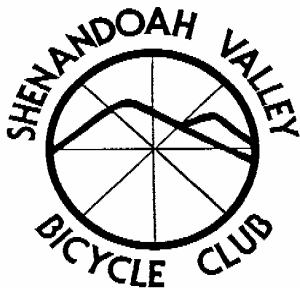
